**PERSONS WISHING TO UTILIZE THIS SERVICE TO OBTAIN GENERAL VOTER INFORMATION, MAY DO SO BY DIALING 1-800-292-0039. ALL POLLING PLACES IN BERGEN COUNTY WILL BE EQUIPPED WITH AUDIO VOTING FOR THE BLIND. VOTERS WHO HAVE DIFFICULTY VOTING DUE TO BLINDNESS, DISABILITY, OR AN INABILITY TO READ OR WRITE MAY BRING A PERSON TO ASSIST THEM AT THE POLLS OR MAY ASK FOR ASSISTANCE FROM THE POLL WORKERS. SAMPLE BALLOTS ARE MAILED TO EVERY REGISTERED VOTER THE WEEK PRIOR TO THE ELECTION LISTING THE OFFICES, CANDIDATES AND THE QUESTIONS TO BE VOTED UPON ALONG WITH YOUR ELECTION VOTING DISTRICTS NUMBER AND POLLING LOCATION.**
