



## Zoo Camp Parent/Guardian Camp Handbook

### Welcome to Zoo Camp

Bergen County Zoo Camp provides a safe environment for your children to learn about wildlife, conservation, and nature to become better environmental stewards. Campers will have daily tours of the zoo and animal ambassador meet and greets. If you have any questions, feel free to contact the education department at 201-634-3108.

### Rules and Protocols

These rules are implemented to ensure the safety of all program participants. Program participants that violate these rules may be dismissed from camp as the Camp Director sees fit. Dismissals are non-refundable.

1. Participants may not bring fireworks, firearms, matches, knives, weapons, or pets to the zoo.
2. Participants are not permitted to leave the camp without being signed-out by a parent/guardian or authorized caregiver. The Director must be informed of early pick-ups during sign-in.
3. Participants, staff, and volunteers are not permitted to smoke, chew tobacco, or vape.
4. The camp staff must be made aware of any allergies or conditions that may require medication. All medications must be in their original containers with the labels still intact and handed to staff during program sign-in.
5. There is a zero tolerance policy for physical or emotional abuse.
6. Chewing gum is not permitted as it can become a choking hazard for participants.
7. Handheld gaming devices and electronics are not permitted during camp.
8. Camp staff is not responsible for damaged, lost, or personal items. Please do not send valuable or cherished items with your child to camp.

### Drop Off

Camp runs Monday through Friday from 9 am –1pm (12pm for Wolf Pups), rain or shine, and takes place both outdoors and indoors. We will attempt to keep children outdoors as much as possible. On days when the weather is poor, we will utilize the education center. Please meet at the front entrance to the zoo (near Parking Lot 1) by 9:00 am each morning. If your child will be late to or absent from camp, please call 201-634-3125. On the first day of camp, you will meet your child's counselor and receive a Zoo Camp T-shirt and nametag. For their safety, children are required to wear their camp shirts **every day of camp**. If a camper has medications that must be accessible to them during the day, the medication must be shown to the camp counselor at check in. All campers must have a completed health packet on file with the camp before they can be dropped off.

### Pick Up

Summer Camp: At the end of the camp day, campers walk to the area behind the carousel. Parents should park in **Parking Lot # 3** (the lot behind the carousel) and meet their children under the trees behind the carousel.

Mini Camp: People approved to pick up campers can meet groups at the front of the zoo, in the same area as drop off.

To sign your child out, you will need to show Photo ID each day so ID number may be written down on form. **No child will be released to any adult who is not on your child's pickup form. Parents and**



**guardians must be named on the check-out form.** If any additions are needed to the original form, a new form may be submitted prior to your child's first day of camp or at drop off **by a parent or legal guardian.** Forms will not be accepted from anyone other than a legal guardian.

### **What Campers Should Bring**

- Wear clothes appropriate for the weather, campers will go outside rain or shine
- Close-toed shoes
- Jackets/coats
- Reusable water bottle
- Snack
- Sunscreen

### **Camp Tips**

- Label all your child's items
- Apply sunscreen and insect repellent before coming to camp (staff is not allowed to apply these items onto children)
- Pack an easy-to-carry snack as they may be eating in different spots around the zoo
- Check weather in the morning, pack sweatshirt or jacket if it will be a cooler or rainy day

### **Program Capacity**

Registrations are accepted in the order in which they are received. After a program has reached maximum enrollment, registration will close. Wait lists will be created on a first come, first served basis; campers will be accepted if an opening should arise. Wait lists do not guarantee the enrollment of a camper(s).

### **Requirements**

Participants must be a Bergen County Resident or a zoo member. Children must be signed up for the appropriate age group. If a camper is signed up for the wrong group, they will be removed from registration.

### **Behavioral Issues**

We expect participants to follow the rules of Bergen County Zoo. Participants will be issued two warnings to allow for behavioral improvement. After the second warning, staff may choose to issue a time-out. When behavior becomes a group management or safety concern, staff will issue a time-out without a warning. The parent/guardian or caregiver picking up the participant will be informed of the situation by a staff member. If a participant's parent has been spoken to more than once throughout the duration of that specific program, and the behavior of the child has not improved, the participant will be removed from the program. Refunds will not be issued for behavioral dismissals.

### **Allergies**

Bergen County Zoo is not a nut free facility. Seeds and nuts are fed to our animals throughout the zoo. Parents/guardians or caregivers of participants with nut allergies or sensitivities should be aware of this and take appropriate precautions.

### **Photo Release**

The Bergen County Zoo takes photographs of participants throughout the duration of the program. Some of these photos will be utilized on the website, social media and/or in an array of marketing material. Be aware that registering for our camp gives the zoo permission to utilize your child's photos.



In general, participants in pictures are not identified. If you wish to exclude your child from photos, please contact the Camp Director.

**Cancellations**

In order to get a full refund, you must cancel three weeks prior to start of camp. Any cancellations later than three weeks in advance are not guaranteed a refund.



## Parent/Guardian Agreement
