BERGEN COUNTY BOARD OF COUNTY COMMISSIONERS ORDINANCE

Ordinance Amending the Bergen County Planning Board's Subdivision Plan Review Fee Schedule

WHEREAS, as was recommended by the Department of Planning and Engineering and the Office of County Counsel;

BE IT ORDAINED by the Board of County Commissioners of the County of Bergen as follows:

SECTION I. The following fee schedule shall be adopted as the *Subdivision Review Fee Schedule of the County of Bergen*:

Initial Filing Fee - Major	\$1,500.00
- Minor	\$900.00
Public Advocate Fee	\$0.00
Exemption Fee - Two (2) copies of minor subdivision	\$250.00
plat and completed County application	
Reprocessing Fee - Revised Joint Report	\$300.00
Processing Fee - Per Lot	\$200.00
Extension Fee/per year - Application must be approved	\$300.00
with (1) calendar year of filing date, or Applicant will be	
required to submit a written extension request along	
with extension fee	
Waiver Fee - per waiver applied for	\$150.00
Final Approval Fee	\$250.00
Violation Fee - Initial	\$125.00
-Additional, per week from date of written notification	\$100.00
until the application receives final approval	
Inspection Fee - 6% of Performance Guarantee (min.)	\$350.00
Permit to Connect to County Storm Drain - per connection \$600.00	

SECTION II. This ordinance shall become effective upon adoption and publication as required by law and upon approval of the Bergen County Executive.

SECTION III. All prior Ordinances or Resolutions or portions thereof of the Bergen County Board of Commissioners inconsistent herewith, be and are hereby repealed.

SECTION IV. If any clause, section or provision of this Ordinance is declared invalid by a Court competent jurisdiction, such position shall be deemed a separate distinct and independent provision and shall not affect the validity of the remaining portion hereof.
