	At Chairperson Gamio's request, Mr. Raguseo gave a brief overview of the Resolutions on today's Special Public Meeting Agenda.	
	Mr. Raguseo then introduced CFO Luppino, who then proceeded to give an overview of this year's budget. He explained that the General Fund includes BCIA's financing issues; Hospital Fund is BNBMC Budget; and Landfill Budget is debt service on Overpeck, for which this will be its final year as its bonds	

will be paid off. The budget includes a carrying expense for a small parcel of golf course land that we recently acquired. The Golf Course Notes are coming due in June. The County is planning to use Open Space Funds and Green Acre Funding to acquire this property rather than to reissue debt. Today's resolution is for the Introduction of the Budget. Once approved by Trenton, we expect to adopt the Budget at our March 5, 2020 Public Meeting. There will be a hearing during our March 5, 2020 Public Meeting to answer any questions that the Commissioners or the Public may have.
