### About the Course:

This workshop examines what constitutes the ethnic and cultural differences in the assessment and treatment of individuals. Being culturally competent is crucial in providing an effective diagnosis.

## About the Instructor:

Dr. Paula Rodríguez Rust is a sociologist (social and behavioral science) specializing in bullying and cultural competence. After teaching for 12 years, she left a tenured Associate Professorship and now works independently with schools and professional medical, social work, judicial, and law enforcement organizations in New Jersey. Services include school climate consulting; student assemblies; parent education; risk assessment including student, staff, and parent surveys; and professional workshops on effective anti-bullying practices, cyber bullying, cultural competence, sexual orientation & gender diversity, and racial, ethnic, & cultural diversity.

This intermediate level workshop is for social workers and social service professionals who are looking to understand how to communicate effectively cross-culturally within their practice.

- Communication differences small group activity on: analysis of a conversation between people of different cultural background: identify the cultural differences underlying the failure to communicate.

- Medical Care and Cultural Misunderstandings.

- Small group activity discussion of hypothetical case study of cross cultural misunderstandings that led to inappropriate patient care.
