#### **About the Course:**

This course will define and differentiate sexual orientation, gender identity and gender expression. It will explore the spectrum and layers of sexuality identity. It will cover what healthcare providers need to know to provide the best care to LGBTQI clients and avoid perpetrating harm or trauma. The course will cover the federal and New Jersey legislation and how these regulations provide protections for LGBTQI and will provide techniques to create a welcoming and affirming clinical practice.
