

## DONATION

Bergen County Meals on Wheels relies on donations. A donation of \$1.25 for each meal is suggested to assist in providing meals to seniors in need.

Each month you will receive a donation envelope & a copy of the planned menu. Please contribute whatever you are able. Service will not be denied if you are unable to donate.

Voluntary donations can be mailed in the self-addressed donation envelope or given to the Meals on Wheels driver in a sealed envelope. If possible, please enclose a check rather than cash.

**Please do not offer your driver a tip. Drivers are not allowed to accept tips.**

## EMERGENCY PREPAREDNESS

**Basic food supplies must be kept in your home at all times.** You may not receive meals as planned on any given day as meal deliveries can be suspended due to severe weather or unforeseen circumstances.

If uncertain whether a delivery will be made, call Bergen County Meals on Wheels at 201-336-7420 between 8:00 AM – 4:00 P.M Monday-Friday.

## RESPONSIBILITY

If you are not home to accept your meal delivery, or if you did not hear the door and the driver left an 'Attempted to Deliver' tag, please call the office at 201-336-7420.

**If we do not hear from you, we will stop your meal delivery and may call the police to check on you.**

## ELIGIBILITY CRITERIA

Bergen County residents who meet the following criteria and reside within the service catchment area are eligible for temporary enrollment in the Bergen County Meals on Wheels program.

- Age 60 years and older; or spouse and caregiver of eligible participants; or age 18-59 with a disability and living alone
- Unable to leave home without the assistance of another person and unable to prepare a nutritious meal for yourself
- Has daytime assistance for no more than 4 hours per day
- Not a Medicaid recipient of Managed Long Term Support Services (MLTSS)
- Does not require a special diet

**A social worker will periodically conduct an in-home interview to determine your eligibility for continuation in the program and identify other services that may benefit you.**

### HOW IT WORKS

A nutritious hot meal is delivered directly to your home each weekday, Monday-Friday, between 9:00 a.m. and 2:00 p.m. An effort is made to deliver the meal at approximately the same time each day.

The mid-day meal consists of an entrée (meat, potato, vegetable, or equivalent), milk, bread, juice, and dessert.

**You must be home to accept your delivery and make contact with the driver.**

**If you have a doctor's appointment or will be away, please call the Meals on Wheels office before 12:00 noon the business day before** at 201-336-7420. Meal delivery will be temporarily suspended and resumed when we are notified. Failure to notify us may result in suspension from the program.

Food is a valuable commodity that should not be wasted.

### WEEKEND MEALS

Individuals at high nutritional risk may apply for a 2-pack of frozen meals to be delivered during the week for consumption on the weekend.
