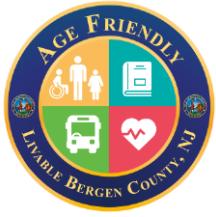

SENIOR FARMERS' MARKET NUTRITION PROGRAM

The Senior Farmers' Market Nutrition Program (SFMNP) offers low income Bergen County residents age 60 or older, assistance in the form of e-benefits in the amount of \$50.00. Benefits can be used towards the purchase of fresh NJ grown produce (fresh fruits, vegetables and herbs) at USDA approved farmers markets.

2023 Qualifying monthly household income must be at or below:
\$2,248 for household of one (1)
\$3,041 for household of two (2)

Apply in person on scheduled dates at selected sites across Bergen County.
Proof of Age, Bergen County Residency and Income is required at the time of application.
