The Senior Farmers' Market Nutrition Program (SFMNP) offers low income Bergen County residents age 60 or older, assistance in the form of e-benefits in the amount of \$50.00. Benefits can be used towards the purchase of fresh NJ grown produce (fresh fruits, vegetables, herbs and honey) at USDA approved farmers markets.

2024 Qualifying monthly household income must be at or below:

\$2,322 for household of one (1)
\$3,152 for household of two (2)

Apply in person on scheduled dates at selected sites across Bergen County.

Proof of Age, Bergen County Residency and Income is required at the time of application.
