INSTRUMENTAL AND VOCAL MUSIC APPLICATION INSTRUCTIONS

The final application form is due on January 18, 2019. Your registration fee entitles you to a total of five (5) musical entries. One small and one large vocal group AND one small and one large instrumental group AND (NEW) one Piano performance. You may not send two groups in any one category without paying the additional required fees. Please submit a separate application for each of the entries.

The 5 entries (1 of each type maximum) may be selected from the following:

Vocal – Solo/Duo/Small Group (up to 10 people)	15 Min. Maximum
Vocal – Large Group (over 10 people)	20 Min. Maximum
Instrumental – Piano Performance	15 Min. Maximum
Instrumental – Solo/Duo/Small Group (up to 10 people)	15 Min. Maximum
Instrumental - Large Group Concert Band/Orchestra	20 Min. Maximum
Instrumental – Large Group Jazz	30 Min. Maximum

- 1. Time limits <u>include set-up</u>, <u>warm-up</u>, <u>performance</u>, <u>critique</u>, <u>and break-down time</u>. Time limits will be enforced. Performers that run over the time allowed will be asked to stop.
- 2. We ask our critique personnel to follow the time schedule as rigidly as possible. Groups or individuals that perform longer within the time limit allotted will receive less critique. For instance, a large group Concert band that takes 19 minutes to set-up, warm-up and perform will receive, at most, 1 minute of critique. **Please plan accordingly.**
- 3. Please register for the appropriate site. Large groups are over 10 students and Small Groups are 10 students or less. Groups that do not conform to the appropriate participant limit will be asked to perform with appropriately populated groups or THEY WILL BE ASKED TO LEAVE WITHOUT PERFORMING. Ignoring these limits has created difficult situations in the past for both the critique personnel and performers.
- 4. Piano Performance –Piano performance will be a separate category and each entering school will receive one 15 minute time slot per application fee. Two pianists per slot are acceptable but will decrease the critique time for each. The time schedule will be strictly adhered to. PLEASE NOTE Piano Performance will be on a recently tuned upright Piano in a classroom. No other venue or instrument is available.
- 5. For vocal music, we strongly prefer live accompaniment. You may bring an accompanist to play with your group. If you must use a recorded accompaniment, it is your responsibility to supply a sound system for playback. A music stand will be provided for the conductor of a large group vocal music performance.
- 6. Please supply the critiquer with copies of music prior to your performance.

- 7. Four Timpani, one xylophone, one bass drum and approximately 70 music stands will be provided in the gym for large instrumental performances. A standard drum set, a guitar amp and a bass amp will be provided in the student center for jazz group performances. This year we will also provide a "standard" keyboard and amp. Equipment details will be available in the spring If you require other instruments for your performance, you must bring them yourselves.
- 8. All students should be present at least two groups before your scheduled performance. <u>If</u> your group is not ready to perform when scheduled, the next group will be called and, if necessary, your performance will be placed at the end of the schedule.
- 9. We will provide three large instrumental group sites one for Concert Bands, one for Orchestras and small group string groups and one for Jazz/Rock groups. Please indicate on your application form the type of group that you will be bringing to the festival. This does not increase the number of Large Instrumental Music Groups that you can bring to the festival with your base registration fee. It remains one either Concert Band, Orchestra or Jazz/Rock Group.

Additional entries over those included in your school Registration Fee will be accepted as our schedule permits. The fee for additional entries is \$20 per student.

Small Group Instrumental Music Application Form 2019 Solo/Duo/Small Groups (10 students or less)

Your registration fee entitles you to choose one (1) Small Instrumental entry, one (1) Piano performance and one (1) Large Instrumental entry. Multiple performances by different solos or groups are permitted within the 15 minute time limit (performance and critique) in Small Group Instrumental Music. Entries that exceed the time limit will be assessed additional charges. Please be sure to enter your group in the proper classification - small groups are 10 students or less; large groups are more than 10 students. Groups who have inappropriately registered will not be permitted to perform.

No other venue or instrument is available.
